Minutes from February 17, 2011 Meeting

The minutes from the February 17, 2011 IBPA Board Meeting were reviewed. Jay VonCannon made a motion to accept the minutes. The motion was seconded by Tammy Doyel and all voted in approval.

Treasurer's Report

Nancy LeCompte presented the Treasurer's Report. Our February donations totaled \$250 and our current balance is \$8,168.66. Nancy also noted that on May 13, 2010 The IBPA Board voted to give Arts Partners \$400 at Mrs. Frey's request. However, that proposal was funded through a grant so the \$400 will go back into our fund.

There was discussion about the amount of money we want to carry over to the next year and whether we may want to review previous partially funded grants and consider offering more support. It was agreed that we do not need to finish the school year with a large surplus. Board President, Deirdre O'Farrell offered to review previous requests and confer with Mr. Shook to see if there are other areas the IBPA Board can support financially.

Jay VonCannon moved to accept the Treasurer's Report. The motion was seconded by Will Klunder and passed unanimously by the Board.

IB Coordinator's Report

Mr. Shook reported that we received another Thank You from Mr. Gallagher's study groups for our support by purchasing pizza for their meetings.

Mr. Shook also reported that 126 freshmen students have accepted a position in the IB program next year.

Mr. Shook announced that the new graduation requirements will be available as summer school classes this summer. There were 33 sophomore students who expressed an interest in completing the classes during the summer so they will have 2 offerings of each class. The Career Technical Education (CTE) class will be a Computer Applications class and there will be the Financial Literacy class. Summer school will run Monday thru Thursday June 6 – June 23.

There were no Proposals for Requests for Funding submitted for this meeting.

New Business

Positions for the new slate of officers were discussed and will be finalized at our next meeting on April 21, 2011. We will need someone to work with Mary Shepherd over the next year and learn the ropes of creating the Newsletter so this person can take it over when she retires.
